**ABSTRAKSI.**

Nilai sebuah perusahaan dapat dilihat dari kinerja keuangan perusahaan. Ada banyak penilaian kinerja keuangan perusahaan, diantaranya adalah *Return On Equity* (ROE) dan *Economic Value Added* (EVA). Kinerja keuangan akan berpengaruh positif terhadap nilai perusahaan. Adanya perbedaan hasil dari penelitian sebelumnya ditambah dengan data riil yang tidak sesuai dengan teori menjadi latar belakang penelitian ini dilakukan.

Jenis penelitian ini adalah asosiatif kausal, dengan metode dokumentasi yaitu mengumpulkan data terkait variabel yang diperlukan dalam penelitian ini yakni ROE, EVA dan nilai perusahaan yang diprosikan dengan *Per Book Value* (PBV). Sampel dalam penelitian ini adalah perusahaan sektor pertanian dan sektor pertambangan yang menerbitkan saham dalam kelompok Daftar Efek Syariah pada tahun 2010-2012 dengan jumlah 51 sampel.

Berdasarkan hasil penelitian, pada pengujian secara parsial ROE berpengaruh secara signifikan terhadap nilai perusahaan sementara EVA tidak berpengaruh secara signifikan pada tingkat kepercayaan 95%. Secara simultan, ROE dan EVA berpengaruh secara signifikan terhadap nilai perusahaan. Hasil penelitian ini diharapkan dapat memberikan informasi kepada investor dan calon investor, perusahaan dan regulator dalam pengambilan keputusan.
